It is an honor to be part of the conversation on harnessing the data revolution for sustainable development, ably championed by H.E. Hon William Ruto, Deputy President of the Republic of Kenya.

The need to use data for better decision-making, resource use and coherence will perhaps be the defining aspect of our National vision and ultimately, the Sustainable Development Goals Agenda. It is my hope that other County Governments will join me in being a part of the partnership for harnessing the data revolution for sustainable development, and ensure that data drives our devolution process and improves services to our citizens.
