

Niger is part of two regional economic communities (RECs) – the Economic Community of West African States (ECOWAS) and the Community of Sahel-Saharan States (CEN-SAD)







Intra-Africa tariffs

Niger subscribes to the ECOWAS ETLS enabling all qualifying goods sourced from approved producers in the other ECOWAS member states to be imported into Niger duty-free. Goods imported from CEN-SAD countries, which are not ECOWAS member states (including Egypt, Morocco, Somalia and Tunisia) and the rest of Africa are levied the MFN applied duty. The MFN applied duty of Niger is the ECOWAS CET which have five tariff bands – duty-free, 5%, 10%, 20% and 35%.





African imports from outside ECOWAS are levied MFN applied duties (ECOWAS CET)

Of the top 20 products Niger imports from African countries outside ECOWAS, the only products imported duty-free are medicines, diagnostic reagents and completely knocked down units of diesel goods vehicles. Most imports are levied 20% import duties, including wheat flour, pasta, second-hand clothes, Portland cement and prepared sardines. 35% duties are applicable to imports of fully built diesel goods vehicles and soaps, while 5% duties are levied on imports of steel towers, protein concentrates, dates, wheat groats and meal, unsweetened milk and cream and certain medium oils.






