1. Introduction

Togo is part of two Regional Economic Communities (RECs) - the Economic Community of West Africa (ECOWAS) and the Community of Sahel-Saharan

- States (CEN-SAD).

 ECOWAS has 15 member states. All member states are part of the ECOWAS Free Trade Area (FTA), 14 of which are in the process of implementing the ECOWAS Common External Tariff (CET). Qualifying imports from approved ECOWAS producers are imported into Togo dutyfree, and Togo applies the ECOWAS CET on imports from outside the REC
- CEN-SAD currently has 24 member states aspiring to establish an Economic Union which includes the free movement of goods, services and commodities. There is currently no free trade agreement in place.



2. Intra-Africa trade

For 2019, 72% of Togo's world exports & 20% of world imports were to and from the rest of Africa. Intra-Africa exports amounted to US\$740 million (3% more than in 2018) intra-Africa imports to US\$393 million (6% less than in 2018).

The main export products are electrical energy, cement, goods packaging articles, make-up preparations, motorcycles, palm oil, cotton woven fabrics, & concentrated milk and cream. The main import products are electrical energy, frozen fish, cement, wheat or meslin flour & petroleum oils.

Electrical energy accounts for 30% of Togo's intra-Africa imports. Togo mainly trades with fellow members of CEN-SAD and ECOWAS, except South Africa. Ghana is the main intra-Africa trade partner - accounting for 17% of Togo's intra-Africa trade.

3. Intra-Africa tariffs & non-tariff cost of

Qualifying goods from ECOWAS member states enter Togo duty-free, while imports from CEN-SAD countries, which are not ECOWAS member states (including Egypt, Morocco, Somalia & Tunisia) and the rest of Africa are levied the MFN applied duty, which is the ECOWAS CET. The ECOWAS CET has five tariff bands - duty-free, 5%, 10%, 20% and



3% of Togo's world exports (4% of intra-Africa exports) are to African countries not ECOWAS member states. Export products include coffee, skin products & bulldozers - accounting for 20%, 12% & 12% of Togo's intra-Africa exports respectively. Other exports include human hair, second-hand clothing & polyethylene bags. 27% of Togo's exports to African countries outside ECOWAS go to Morocco, 19% to Congo, and 14% to Gabon.


5% of Togo's world imports (27% of intra-Africa imports) are sourced from outside ECOWAS. Togo mainly imports pacific salmon, electricity meters, fertilisers, diesel trucks, cane or beet sugar & diammonium phosphate from African countries outside ECOWAS countries. 23% of Togo's imports from non-ECOWAS countries are sourced from Morocco, and 22% from South Africa, 20% from Mauritania and 19% from Egypt.

All of Togo's world imports of electricity meters & diammonium phosphate are sourced from non-ECOWAS African countries; also 92% of world imports of fertilisers, and 62% of diesel trucks are sourced from African countries outside ECOWAS.

Of the top 20 import products, only 2 products are duty-free diammonium phosphate and urea. The highest tariffs (20%) are applicable to imports of cane or beet sugar, canned sprats & paper bags. A 10% duty is levied on imports of pacific salmon, electricity meters, diesel trucks, frozen fish, odoriferous mixtures for food and beverage, medium oils (n.e.s) & plasters. A 5% duty is applied to imports of fertilisers, polyethylene, coal, polypropylene & control panels.

The non-tariff cost of bilateral trade between Togo & designated trade partners

The ESCAP-World Bank trade cost database includes the cost of transportation and the time to complete import procedures and obtain necessary information as non-tariff costs affecting bilateral trade between trade partners. The data shows that the cost of trade between Togo with African like Tanzania, DRC, Kenya and Egypt is more than the cost of trade between Togo and non-African countries like the UK, France and China. The costs of trade between Togo and fellow CEN-SAD or ECOWAS member states (Ghana, Burkina Faso, Benin, Ivory Coast & Nigeria) is low. However, the cost of trade between Togo and Gambia (a member of CEN-SAD and ECOWAS) is more than the cost of trade Togo and non-CEN-SAD or ECOWAS African countries like South Africa, Algeria & Cameroon), and non-African countries like China and
