


Regional Economic

Malawi is a member of COMESA and SADC. It also has bilateral preference arrangements with Botswana; Mozambique; South Africa; and Zimbabwe. It is currently negotiating the Tripartite Free Trade Area.

COMESA has 19 member states of which 16 are part of the COMESA FTA. Swaziland has preferential access under derogations but is exempt from reciprocating preferences due to its membership of SACU. The DRC, Eritrea and Ethiopia are in the process of joining the FTA.

SADC is a Regional Economic Community with 16 member states, of which 9 are also members of COMESA. 13 SADC members are in a Free Trade Agreement (FTA); Comoros, DRC and Angola are yet to join the FTA.





The majority of Malawi's intra-Africa imports originate from SADC and COMESA where they are accorded preferential access.

Malawi imports less than 1% (US\$1.7 million) of its intra-Africa imports from non-SADC or non-COMESA Áfrican countries.

The majority of Malawi imports originate from SADC and COMESA states. Very little originates from rest of Africa

MFN applied duties

Outside SADC & COMESA, tariffs applied range from 10% - 30%; however this accounts for only 1% of total intra-Africa

Duty free imports

More than 90% of imports originating from Africa SADC) enter Malawi duty free; only 263 product lines (HS8)from COMESA


