AFRICAN GROUP TEXTUAL PROPOSAL ON A DECLARATION FOR THE 10TH WTO MINISTERIAL CONFERENCE

The following communication, dated 10 November 2015, is being circulated at the request of the delegation of the Kingdom of Lesotho on behalf of the African Group.

INTRODUCTION

1. The African Group is a strong supporter of a rules based multilateral system that seeks to integrate African Countries into the Global Trading System and prioritizes the needs of developing and least developed Members of the WTO. The Group strongly believes that the DDA negotiations must achieve an objective set out in the Doha Ministerial Declaration, namely that, "seeks to place the needs and interests of developing Members at its heart and continue to make positive efforts designed to ensure that developing Members, and especially the LDCs secure a share in the growth of world trade commensurate with the needs of their economic development".

2. The essence of this submission is to reaffirm Members' commitment to adhere to and respect all mandates for the Doha Development Agenda (DDA) and for the post MC10 remaining DDA issues to continue being negotiated within the DDA framework and respective mandates. Moreover, the essence of the submission is to preserve key principles enshrined in DDA mandates such as the development dimension in its various manifestation, special and differential treatment, less than full reciprocity, decision making by consensus and single undertaking.

3. The African Group considers the WTO to be a key part of the global economic governance. In this capacity, the WTO is expected to make tangible contributions to the sustainable development goals under the auspices of the Post -2015 Development Agenda adopted by the United Nations.

4. In view of the foregoing, the African Group hereby submits a textual proposal¹ aimed at contributing towards consultations on the content of the outcome document for the Tenth WTO Ministerial Conference (MC10) to be held in Nairobi, Kenya during 15 - 18 December 2015. The submission is limited to Parts I and III of the Declaration. The Group pledges its full cooperation with all Members with a view to ensuring that MC10 becomes a resounding success.

NAIROBI MINISTERIAL DECLARATION ADOPTED ON 18 DECEMBER 2015

1 PART I

1.1. We, the Ministers, have met in Nairobi, Kenya, from 15 to 18 December 2015 at our Tenth Session. As we conclude our Session, we would like to express our deep appreciation to the Government and people of Kenya for the exceptional organization and the warm hospitality we have received in Nairobi.

1.2. We reaffirm the principles and objectives set out in the Marrakesh Agreement Establishing the World Trade Organization and recall the Declarations and Decisions we adopted at Doha and at the Ministerial Conferences we have held since then and reaffirm our full commitment to give effect to them.

1.3. We take note of the reports from the General Council and its subsidiary bodies. We welcome the progress arising from these reports, and the Decisions stemming from them, in strengthening the effectiveness of the WTO as an organisation and the multilateral trading system as a whole.

1.4. We further welcome the advances made in the Doha Development Agenda (DDA), as represented by the Decisions and Declarations we have adopted at our present session. These Decisions and Declarations signify that we have taken yet another step forward in the negotiations and attest to our strong resolve to complete the DDA as has been reaffirmed by our Leaders in the Sustainable Development Goal 17.10.

1.5. We reiterate the need for the WTO to remain the premier negotiating forum to improve multilateral trade rules and respond to the dire need for this institution to deliver on substantive market access for trade and competitiveness of our weaker and vulnerable Members, in particular LDCs. However, it is imperative that the achievements we have made overtime on inclusive, Member-driven, consensus-based, and transparent conduct of negotiations should be maintained.

1.6. We recognise that the DDA is a significant multilateral attempt to respond to trade and development interests of developing Members and redress the imbalances codified in the rules resulting from the previous rounds of multilateral trade negotiations. Further we recognize that a comprehensive conclusion of the DDA with economically meaningful and balanced outcomes will provide impetus to global trade liberalization and facilitation, and improve the trading prospects of developing Members, and enhance the primary role of the WTO in global trade governance.

1.7. We recognise and affirm the role the WTO can play in contributing towards achievement of 2030 sustainable development agenda.

2 PART III – POST NAIROBI WORK

2.1. We reaffirm our commitment to the WTO as the pre-eminent global forum for trade, including negotiating and implementing trade rules, settling disputes and supporting development through the integration of developing countries into the global trading system. In this regard, we further reaffirm our commitment to the Doha Development Agenda.

2.2. We furthermore reaffirm, the Ministerial Declarations and General Council Decisions relevant to the Doha mandates and commit to take concrete steps to conclude remaining negotiations issues under the DDA framework.

2.3. We take note of the progress that made towards carrying out the Doha Work Programme, including the decisions we have taken during this Ministerial Conference. These decisions are an important stepping-stone towards the completion of the Doha Round. We reaffirm the Declarations and Decisions we adopted at Doha, and all subsequent Declarations and Decisions including the Decision adopted by the General Council on 1 August 2004; the Hong Kong Declaration of 2005; the Bali Ministerial Declaration of 2013.

2.4. We recognise that all participants have worked hard and constructively to make progress required under the Doha mandates and acknowledge some progress has been made to date. We equally recognise that more work needs to be done to enable us to proceed towards the full, successful and multilateral conclusion of the negotiations pursuant to paragraphs 45, 47 and 48 of the Doha Ministerial Declaration in fulfilment of the commitments we took at Doha. In those areas where we have reached a high level of convergence on texts, we undertake to maintain this convergence as the basis for further negotiations towards the conclusion of the DDA.

2.5. Taking note of the progress made so far, we instruct our officials to continue working on outstanding issues of the Doha Development Agenda with a renewed sense of urgency under the auspices of the Trade Negotiations Committee. Further, we instruct the Chairman of the General Council to convene a special meeting of the General Council no later than 31 March 2016 and every three months thereafter to review the progress of work done towards expeditious and successful conclusion of the Doha Development Agenda in a time-bound manner.
